\*\*There is a **<u>Public Nuisance Law</u>** that is being enforced in our community.

- All pets must be kept on a leash or in a fenced yard.
- Law prohibit any vehicles to be in plain sight of the street that do not have current registration and inspection stickers. This includes boats.
- Trash will not be allowed to accumulate.
- Grass must not be more than 12 inches high.
- Any structure must be of sound construction and maintenance, and not constitute a fire hazard.

Full details of this Law are available. Citations are given to property owners by the County Fire Marshal's Department for violations.

# **Frequently Asked Questions:**

<u>Where do I get a key to the Park and Boat Ramp</u>? Contact <u>thunderbirdshores@gmail.com</u> or leave a message at: 903-257-5950 to make arrangements to purchase a key on the first Saturday of the Month. The keys are \$25 each; your annual POA Dues **must be current** in order to purchase a key.

**How often does the POA meet**? Community meetings are held on the second Saturday in April and September. The meetings usually last about an hour. Notices are posted on the bulletin board at the entrance to Thunderbird Shores as well as on our Facebook and Website.

How much are the POA dues, and when do I pay them? Dues are \$75 per year, per lot. Statements are mailed in January and are due by March 31st.
